3. **Entry Period:** The “iPod Nano – Cheater-Chat.com” Sweepstakes commences at 12:00 p.m. (EST) on July 25, 2010 and ends at 12:00 p.m. (EST) on September 30, 2010. All entries must be received by 12:00 p.m. (EST) on September 30, 2010.
4. **How to Enter:** Participants may enter the Sweepstakes online at Cheater-Chat.com. To enter online, sign in to the Cheater-Chat forum within the Wood-Hitchcock, Inc., Cheater-Chat.com website <http://www.cheater-chat.com>.
5. **No Limit Entries:** Participants may enter as many times as they like, there is no limit. No responsibility is assumed and entrants or participants waive all claims for failure of any entry received by Sponsor on account of technical problems on the internet or computer malfunctions, or undeliverable, late, illegible, incomplete, misdirected entries, postage-due mail, or any other means.
6. **Prizes:** One winner will be selected by an impartial chosen Judge to select the top ten finalists. Then a team of three Judges will make the final decision of the winner’s entries. The winner chosen will receive one (1) 8 G iPod Nano. No substitution or transfer of prizes permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize is unavailable. The winner will be notified by e-mail, within three (3) days after the drawing. Odds of winning depend on number of qualified entries received. Winner will be awarded iPod color of their choice, if unavailable or iPod color is sold out their secondary color will be selected for them.
